3. Our aim is to provide this service for the lowest possible fee – currently at 95 Euro per wine submitted.
4. A single wine entry / submission consists of 6 bottles of exactly the same wine, same vintage.
5. Wine samples should be shipped "Door to Door" tax paid – wineries can use their own shipping company or Postal Service.
6. Please ensure entry form completed and copy with samples, and a copy emailed to winesofadelaide@gmail.com
7. A company can pay the submission fee when wines are received in Australia. A tax invoice will be emailed.
8. Once received Wines of Adelaide will:
 - a. Review your supplied tasting notes, any reviews and prices
 - b. Contact qualified, licenced wine importers and distributors regarding available samples and make appointments to introduce the brand personally (Importers are located in Adelaide, Melbourne and Sydney)
 - c. Conduct a professional judging / media review of the wine and place on appropriate Social Media. Winery may use these results for their own marketing benefit if desired.
 - d. Meet the appropriate importers / distributors and present the wines and follow up directly on your behalf.
 - e. Within 90 days report directly back to the winery by email with tasting results, comments / feedback from the importers.
